



CONSENT FOR PERSONAL DATA PROCESSING

By signing this Consent, I agree that the Company checks my Personal Information contained in the documentation I have provided in publicly available databases as well as other publicly available sources. Also, I confirm that, for the purpose of assistance in the recruitment process (sorting and rating candidates) I agree with the Company hiring third parties (employment agencies, external consultants) and shares my Personal data with them.

Furthermore, I confirm that I have been notified that:

- the Company is the Data Controller of my Personal data;
- the Company processes my Personal data based on my voluntary consent;
- my Personal data will be processed by the Company for purposes and in deadlines hereby defined, for as long as my consent is valid, i.e. until I withdraw it;
- In accordance with the General Data Protection Regulation 2016/679 (GDPR) I have the right to request from the Company, using one of the provided contact information (i) access to my Personal data (ii) rectification of my Personal data (iii) erasure of my Personal data (iv) restriction of processing of my Personal data (v) a right to object to the processing of Personal data and (vi) exercise of the right of Personal data portability.
- I have the right to lodge a complaint to the supervisory authority (Personal Data Protection Agency – AZOP) if I believe that the processing of my Personal data is not in accordance with the rules prescribed by GDPR;
